Trademark Registration 商标注册 (Singapore 新加坡)

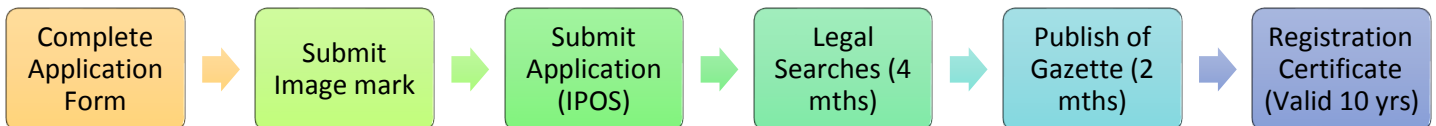
Trademark is a legal right for an individual or body corporate to own and the exclusivity of one's design, brand, or logo to be use in certain countries. Trademark registration ensures exclusive right and protection over the brands that is registered and can give rise to legal action and claims for compensation on any infringement on those rights.

- Place of Usage: Republic of Singapore only
- Validity: 10 years (renewable)
- Ownership: Individual or Body Corporate
- Price: SG\$1,241.-
- Lead time: 6 months

Advantages:

- ✓ Owing one's own unique branding
- ✓ Increase higher quality appearance of the company
- ✓ Protect Intellectual property rights
- ✓ Develop easier, marketable, and local branding that is easily recognizable to the public
- ✓ Trademark can easily become a profitable asset and measure of one's successful branding and of the company
- ✓ Allow a reasonably higher rise to take legal action on any infringements on those trademark rights.
- ✓ Successful trademark rights gives the owner 10 years rights and unlimited years of that trademark rights upon every 10 years renewable ahead.

Workflow:



1. One does not required to come over to Singapore, to register a Singapore trademark, all can be done virtually with us
2. Complete SBC Trademark Application Form
3. Submit an image mark
4. Upon payment, Application submission to IPOS Government
 - Trademark registry run on a “first-come, first –serve” basis
5. Legal Comprehensive Searches & Approval by IPOS
 - The sample of the trademark will be conducted for similarity trademark search.
 - Time length: 4 months.

1. IPOS publishes marks
 - The trademark will be published in the gazette.
 - Time length: 2 months.
7. Upon no objection, IPOS issuance of trademark certificate

Any opposition during publication period or re-issue of examination report will require additional time by the IPOS.

Remarks:

- Provided with 2 free registration searches in which an additional charge would apply to the 3rd registration searches.
- The trademark registration fee only cover 1 type of trademark classification.
- Additional classification would incur additional charges per classes; government fee charges additional classification of goods and services.
- Renewal registration shall be applied before the expiration date in order to avoid any “Late Renewal Penalties and Surcharge”

Workflow:



1. 公司注册商標无需客户到访本司办理
 2. 填写 SBC 商標注册申请表格
 3. 提交图片标志
 4. 一旦确应款项，将会提交申请表格给 IPOS 政府
 - 商標注册由‘先到先得’的理念办理
 5. IPOS 检查以及审批
 - 商標的样本将进行搜索，寻找相似的商標
 - 申请时间：4 个月
 6. IPOS 制作商標图案
 - 一旦审批通过，商標将立即发布
 - 申请时间：2 个月
 7. 若无反对，IPOS 将会正式发出注册证书
- 如出版期间有任何反对或重新申请审查报告，IPOS 将需要额外时间处理

备注:

- 提供两次免费注册商標搜索，第三次以上需缴费
- 注册商標费用只概括一种商標类别
- 附加的商標类别会引起多余费用；政府也额外收费
- 为了避免任何“迟于更新罚款以及政府追加罚款”的事情发生，公司更新注册商標费用将在截止日前获得提醒
